SOLID WASTE HAULER LICENSING APPLICATION

A Waste Hauler license issued by the Boston Mountain Solid Waste District is required for anyone engaged in the business of collection or transportation of solid waste within Washington & Madison Counties, Arkansas. Waste haulers are required to comply with all applicable District Rules & Regulations. A copy of the Rules & Regulations are available online (www.bostonmountain.org) or by contacting the District office.

A solid waste hauler's license issued by the District does not supersede any local government's issuance of an exclusive franchise for hauling within its boundaries.

Good cause may be a history of failing to pay bills or other disputes between the customer and hauler. The location of the customer will not be considered good cause.

9. PAY AS YOU THROW (PAYT) PROGRAM

A PAYT Program (also known as unit pricing or variable-rate pricing) requires that residents be charged for the collection of solid waste based on the amount they throw away, creating a direct economic incentive to recycle more and to generate less waste.

You are required to attach a copy of your business's rate schedule indicating your PAYT pricing structure showing residents will be charged based on the amount of solid waste they throw away.

Example: 1-3 bags: \$20, 4-6 bags \$25. Please contact the District office if you have questions regarding this.
